

# Privacy Policy for X-Ray LLC

At X-Ray LLC, accessible from web3jobs.online, one of our main priorities is the privacy of our visitors. This Privacy Policy document contains types of information that is collected and recorded by X-Ray LLC and how we use it.

## General Data Protection Regulation (GDPR)

We are a Data Controller of your information.

X-Ray LLC legal basis for collecting and using the personal information described in this Privacy Policy depends on the Personal Information we collect and the specific context in which we collect the information:

- X-Ray LLC needs to perform a contract with you
- You have given X-Ray LLC permission to do so
- Processing your personal information is in X-Ray LLC legitimate interests
- X-Ray LLC needs to comply with the law

X-Ray LLC will retain your personal information only for as long as is necessary for the purposes set out in this Privacy Policy. We will retain and use your information to the extent necessary to comply with our legal obligations, resolve disputes, and enforce our policies.

If you are a resident of the European Economic Area (EEA), you have certain data protection rights. If you wish to be informed what Personal Information we hold about you and if you want it to be removed from our systems, please contact us.

In certain circumstances, you have the following data protection rights:

- The right to access, update or to delete the information we have on you.
- The right of rectification.
- The right to object.
- The right of restriction.
- The right to data portability

## Log Files

X-Ray LLC follows a standard procedure of using log files. These files log visitors when they visit websites. All hosting companies do this and a part of hosting services' analytics. The information collected by log files include internet protocol (IP) addresses, browser type, Internet Service Provider (ISP), date and time stamp, referring/exit pages, and possibly the

number of clicks. These are not linked to any information that is personally identifiable. The purpose of the information is for analyzing trends, administering the site, tracking users' movement on the website, and gathering demographic information.

## Data That We Collect

We collect the following data from you when you use Tonpro Website:

- **Telegram account data:** X-Ray LLC uses your public Telegram profile data, such as your ID and Name, to facilitate scheduling and communication between you and your contacts. We respect your privacy and do not share your Telegram data with any third parties. We only store your public Telegram ID and Name.
- **Browser data:** X-Ray LLC stores and uses your timezone provided by the browser to display events in your local time and to send you reminders about upcoming events. Timezone is also used to adjust your schedule to the timezone of your contacts when you share it with them. We respect your privacy and do not share your timezone data with any third parties.

## Children's Information

Another part of our priority is adding protection for children while using the internet. We encourage parents and guardians to observe, participate in, and/or monitor and guide their online activity.

X-Ray LLC does not knowingly collect any Personal Identifiable Information from children under the age of 13. If you think that your child provided this kind of information on our website, we strongly encourage you to contact us immediately and we will do our best efforts to promptly remove such information from our records.
